### **TEAMS MUST CHECK IN BY 5:00 PM ON DECEMBER 29, 2017**

Team Check-ins is very busy. DA L.I.S.T., Inc. strongly recommends the teams to check-in as early as possible. Note: Parents are not required for the team check-ins, but are allowed.

### **GAME SCHEDULES**

When your team checks in for the tournament, you will receive your game schedules. These schedules are subject to change.

### **SPECIAL REQUESTS ARE POSSIBLE BUT NOT GUARANTEED**

Special requests on game days and/or times due to travel schedules have occurred in the past. DA L.I.S.T., Inc. will attempt to accommodate these requests. Any special requests will be reviewed on discretionary basis. Special requests for game days and/or times are not guaranteed.

### **TEAMS AND PLAYERS MUST HAVE REQUIRED EQUIPMENT**

Please ensure all players have the necessary equipment to compete. All players must have a mouth piece which attaches to the helmet, facemask, and a cup and supporter. Failure to have the proper equipment will result in a player being ineligible to compete in the tournament. Steel tipped cleats is prohibited.

## **GOOD SPORTSMANSHIP IS MANDATORY**

Ensure all participants understand “Good Sportsmanship”. It is our experience that during a game, each team can expect to receive questionable calls by the officials. Do not argue with the referees. If you would like to discuss an official’s call, speak **ONLY** to the White Hat; and not the Line Judge. All officials are High School officials, but mistakes can be made.

## **PLAYER EJECTION FROM GAME**

Should the Game Officials eject a player, it may jeopardize that player’s ability to continue competing in the Tournament. Fighting by anyone will result in a game ejection and removal from the remainder of the Big Dog Bowl 2018. Head Coaches are responsible for the misconduct of coaches, players, parents, and spectators on their sidelines.

Should a coach or parent be ejected for misconduct, each will be escorted from the Grand Terrace High School property. Should an ejected person fail to immediately leave the game fields when instructed, security personnel will notify the City Police Department to remove each uncooperative person. Please advise everyone on your team, DA L.I.S.T., Inc. takes sportsmanship and proper conduct seriously. Should you need any assistance, locate the nearest DA L.I.S.T., Inc. personnel or tournament security officers.

## **PLEASE DO NOT REMOVE HELMETS OF INJURED PLAYER**

If there is a possible serious injury, do not remove the player’s helmet. DA L.I.S.T., Inc. personnel, security officers, and other first-responders will be responsible for the medical situations.

## **ANY SERIOUS INJURY WILL BE RESPONDED BY CALLING 911**

If any player suffers a suspected and/or actual serious injury, DA L.I.S.T., Inc. personnel, security officers, or other first responders will contact 911 for outside medical and emergency personnel to address the player’s medical condition. Referee will suspend game play until the player is transported to the hospital by responding emergency personnel.

## **NOMINAL COST OF \$5.00 FOR T-SHIRT TO REPEAT CHEERLEADERS**

At the request of teams who attended the tournament in previous years, cheerleading squads attending this year with their team, will also be able to receive an event t-shirt, medallion and patch. There is a nominal cost of \$5.00 per cheerleader for this benefit. This is an optional cost and is solely the discretion of the team. If your cheer squad is interested, please ensure completing the cheerleader participant form.

# **RULE BOOK**

This book contains the forms, rules, policies, and procedures, which must be adhered to for teams that participate in the Big Dog Bowl 2018

The Head Coach of each team that participates in the Big Dog Bowl 2018 is ultimately responsible for all record keeping, team finances, and conduct of all participants (including parents, spectators, etc.) attending the tournament. You may assign a Team Manager to assist with the coordination, communications and record keeping of your team. However, having a Team Manager does not relieve the Head Coach of the ultimate responsibility and consequences for misconduct.

Due to the number of players, cheerleaders, coaches, and parents expected to attend the Big Dog Bowl 2018, DA L.I.S.T., Inc. must limit the authority to contact DA L.I.S.T., Inc. personnel to the Head Coach and/or Team Manager. The tournament will not accept phone calls from parents. Parents must communicate their concerns with their coaches.
